**Objectives:**

- negotiating and consummating real property, zoning development rights or other transactions as buyer, seller, lessee, lessor or otherwise in relation to enabling, implementing, promoting or assisting development and redevelopment activities
- constructing or to engaging, directly or indirectly, the services of contractors to construct improvements in furtherance of development and redevelopment activities
- engaging the services of one or more consultants, engineers, architects, attorneys, advisors, trustees, agents and other persons or entities whose services shall be necessary or desirable in connection with the activities referred to above
- assigning or paying over to the City of Utica, or to such entity as it may direct, as and to the extent that it may direct, revenues derived from or in connection with the Harbor Point redevelopment and/or other sources, and
- performing any and all acts and exercising any and all powers which may now or hereafter be lawful for the corporation to do or exercise under the laws of the state of New York for the purpose of accomplishing any of the foregoing purposes.
