- PO Morinitti always presents a neat and polished appereance and always passes his uniform inspection.
- PO Morinitti only used three sick days during this rating period and never reported late for his tour.
- PO Morinitti was observed one block out of zone by Captain Cinque. When questioned about it he said he had just missed a turn to stay in zone. This incident was documented and has not been an issue with PO Morinitti since.
- PO Morinitti is frequently a top performer in productivity in the platoon.
- PO Morinitti conducts complete and thorough investigations as well as Evidence Technician work. The only issues with PO Morinitti's reports are the organization and grammar of the information itself. They are sometimes written in a way that can be hard to follow, such as in a bullet point / paragraph hybrid format. This has been something PO Morinitti has worked on throughout his career and as his supervisor I have seen a marked improvement in this over time.
- PO Morinitti has a mild mannered demeanor and calming presence when dealing with the public but at the same time he does not hesistate to act or get physical when the situation calls for it. This is a good balance and should be something officers strive to achieve.

PO Morinitti should consider putting in for assignments in CID if they become available.





While in the area, Sgt Cimpi located a male matching the description of the suspect still in the area. Upon being stopped, the male discarded a book bag and fled on foot from Sgt Cimpi. During the ensuing foot pursuit; I, along with members of patrol surrounded the area. After a brief foot pursuit I was able to apprehend the suspect and was quickly assisted by PO Morinitti and PO Jukic in taking the male into custody. The male would later be identified as Brandon McNair.

Upon conducting a backtrack of the pursuit, Sgt Cimpi and PO Rejrat located a loaded and defaced .380 handgun. Video evidence would later be collected showing the male discarding the firearm during the pursuit.

PO DeTraglia secured the discarded book bag which was later found to contain contraband consisting of narcotics pills.

I would like to make note in each respective officers e-file relative to their efforts in taking McNair into custody and removing an illegal handgun from the streets.







On December 1st 2016, Officers Joshua Sweet and Raymond Kellogg were patrolling West Utica when they observed a male subject walking in the area of Court St. The officers knew the man was wanted by the Utica Police Department They attempted to stop and affect an arrest but the subject fled on foot. The officers gave chase and additional units responded to the area. While searching for the male in the area of the brewery, a witness saw a male matching the subject's description discard an item in the rear parking lot of a Varick St. pub. Officer Andrew Morinitti and Officer Kellogg checked the lot and located a .22 caliber pistol.

Officer Sweet and Officer Anthony Aurience continued to search for the male in the area of the bars on Varick St. Officer Aurience then located the male attempting to scale a fence on Varick St. and took him into custody without further incident. The male subject was positively identified as the male who discarded the firearm and was subsequently charged with criminal possession of a weapon and criminal possession of a firearm, in addition to his active warrant. The officers successfully removed from the streets a man who was and is a danger to the community as well as an illegal handgun. Officers Sweet, Kellogg, Aurience, and Morinitti are a credit to themselves and to the City of Utica.
