
On August 31, 2018, at approximately 2:45 a.m., Dispatch advised of a home invasion that had just occurred on Leslie Ave. It was reported that two men had entered the residence armed with handguns and fled after tying up the victims and burglarizing the home. While multiple units were en route, dispatch was advising BOLO information of the suspect vehicle. Officer Patrick Murphy spotted the vehicle, it immediately tried to evade him and a vehicle pursuit was initiated.

The pursuit continued through most of South Utica and into New Hartford. The driver crashed the vehicle and continued to flee on foot, jumping fences in yards with Officers Brian Baye and Murphy in close pursuit. Officer Harrington arrived and cut him off after he jumped another fence. He then held the suspect at gun point until Officers Baye and Murphy caught up and took him into custody. A subsequent search of the suspect's vehicle led to the recovery of a loaded 9mm handgun as well as other articles of evidence relative to the home invasion.

Based on the actions and coordinated efforts of the officers involved, a dangerous armed suspect was taken into custody and charged with multiple felonies by the Criminal Investigation Division. The actions of these officers involved brings honor to themselves and to the Utica Police Department.



Sirs,

On August 19, 2017 at approximately 0227 hrs, multiple units were dispatched to the area of Rick's Place (Lansing St & Mohawk St) for a shots fired. We immediately located the victim/caller Sadan Salkic who stated that a male he knows to be Ray had shot him in the left shin outside the bar. He said that Ray ran into the second floor apartment above the bar.

Long story short we set up a perimeter, began canvassing and located a single 9mm casing in the roadway. Within the first hour we also spoke with Rick Dorsagno, owner of Ricks bar who said that the second floor apartments are all vacant but a Raymond Guarno used to live there. Dorsagno confirmed to me multiple times that the apartments were all vacant and no one should be up there. Inv. Donaldson then requested he sign a search waiver for these apartments along with the key. Dorsagno agreed and signed the waiver.

Once the Waiver was signed we developed a plan to conduct a slow and deliberate search of the second floor. Officer Flanagan and I grabbed the shields from unit 50 and 40 and were followed by Sgt. Goldstein, Officer Bubnis, Officer Parkosewich and Inv. Donaldson. Once on the second floor landing we made contact with the suspect Raymond Guarno and a Joseph Pavia in apartment 1. Both were taken into custody without incident. We then cleared the remaining apartments and ended up locating a loaded 9mm pistol, a large quantity of U.S. currency and a large quantity of what appeared to be crack cocaine.

Guarno was later tested for GSR which tested positive.

A firearms permit tab was created for Guarno.

Charges to be handled by CID and SIU.

All in all everyone involved did a great job which led to this arrest and a closed case.

Dear Chief Williams:

On behalf of the U.S. Probation Office for the Northern District of New York I would like to thank your department, specifically Police Officers Charles Parkosewich and Brian Baye for their outstanding work in the Karen Pepper case on the evening of March 29, 2016. Ms. Pepper had just been released to pretrial services supervision by one of our U.S. Magistrate Judges in Syracuse a few hours earlier and my officers, Senior Probation Officers Ellen Phillips and Tim Nolan had traveled to Utica to conduct a residence check. Upon arriving at the residence my officers met your officers who were responding to a 911 call. Ms. Pepper was found unresponsive at which time your officers administered an opiate overdose antidote, Narcan, and basically saved her life. We were able to secure an arrest warrant as Ms. Pepper violated her release conditions by using heroin, and Officers Parkosewich and Baye remained at the scene and assisted in the case until the U.S. Marshals responded. Your officers assisted the U.S. Marshals Service by transporting Ms. Pepper to the local jail. During that transport, Ms. Pepper decompensated and required another dose of the Narcan, which your officers administered to her. They then sought medical attention for Ms. Pepper (as she had previously refused to go to the hospital).

Officers Parkosewich and Baye handled this situation with the professionalism and compassion. I appreciate the professional courtesy which they extended to our officers as well. You should be very proud of their work.
