





INVESTIGATIVE SKILLS - When PO Wiley is assigned a case he goes above and beyond when investigating each incident. It has been noted on several occasions where PO Wiley has completed tasks beyond the mere investigative measures in attempt to further obtain suspect/lead information.

INITIATIVE - PO Wiley has been noted as being the Top Performer in April, October, and November in regards to the number of parking tickets he wrote each month. PO Wiley also produced a high number of premise checks within the platoon for the year.

CARE AND USE OF EQUIPMENT - In September PO Wiley received a counseling memo regarding an audit that was completed involving the Policy and Procedure involving the completion of the Vehicle Inventory Checklist. PO Wiley failed to complete his checklist on September 1st, 2017 and as a result he received the counseling memo.

ATTENDANCE - PO Wiley utilized 3 sick day for the year.

WORK QUALITY - PO Wiley is very attentive to making sure that he is handling the calls that come out in his zone, but to a detriment where it causes him to fall behind in the timeliness when completing his incident and/or accident reports.

JUDGMENT - In August PO Wiley had a mishap in identifying the suspect of a Larceny incident where the suspect used her sister's pedigree information. As a result a warrant was issued for the suspects sister and PO Wiley had to go back and further complete the necessary steps to charge the suspect with the correct pedigree information.

PO Wiley is a very diligent officer who prides himself on making sure he covers whatever zone he is assigned to. PO Wiley also shows enthusiasm and dedication to the job. In order to improve PO Wiley needs to work on his time management, focusing on making sure he is completing his incidents prior to clearing his calls. PO Wiley should also strive towards being more proactive.

This evening, at approximately 2216 hours, Car 55 (Officer Parkosewich) and Car 54 (Officer Wiley) were dispatched to [REDACTED] regarding a fight call. Upon arrival PO Parkosewich was met by highly intoxicated male, who was identified as Nicholas K. Simmons [REDACTED]. Immediately Simmons was being aggressive towards PO Parkosewich and Simmons' friends, who were attempting to place him into a vehicle to get him to leave. This afternoon, at approximately 1439 hours, Car 55 (PO Mahaffy) and Car 56 (PO Wiley) were dispatched to the second floor apartment of [REDACTED] for a [REDACTED]. When the officers arrived on scene they learned that there was a dispute between the victim/parent, [REDACTED] and the offender/daughter, [REDACTED]. [REDACTED] informed the officers that the dispute was initially verbal, but became physical when [REDACTED] pushed, punched, and grabbed her, and that she wanted [REDACTED] to either leave or she wanted [REDACTED] arrested for hitting her. The officers explained to [REDACTED] her options, but [REDACTED] refused to leave by stating to the officers, "You'll just have to arrest me". At that point [REDACTED] advised [REDACTED] he is under arrest for hitting her. PO Mahaffy and PO Wiley then attempted to take [REDACTED] who was sitting on a couch, into custody. While trying to affect an arrest on [REDACTED] she immediately began resisting by pulling her arms away from the officers grasps, by rolling away from them on top of the couch, and by tucking her arms underneath her body to prevent the officers from handcuffing her. PO Mahaffy and PO Wiley then executed a soft/empty hand come along and take down by grabbing [REDACTED] arms and attempting to place her into a position of advantage. The officers were able to roll [REDACTED] onto the floor, into the prone position, and then handcuff her to the rear without any further incident. Once [REDACTED] was handcuffed the officers stood her up and escorted her outside where she was placed into the rear of patrol car 56. No injuries were reported. The following Response to Resistance investigation was initiated.

On Monday, October 29, 2018 at around 1042 hours Officer Chris Manion and Officer Cliff Wiley responded to a call for service at the St. Elizabeth's Clinic, 120 Hobart Street for a person refusing to leave. Upon arrival Officers Manion and Wiley met with Security Guard David Bunce [REDACTED] who told them that Benito Rodriguez, [REDACTED] came to the facility, became disorderly and was asked to vacate the premise, which Rodriguez refused to comply with, Bunce then called the police. Manion and Wiley then spoke with Rodriguez and advised him that if he did not leave he would be subject to arrest. Rodriguez continued to be argumentative and disorderly. Bunce advised that he would be willing to sign a trespass complaint, which he did.

Rodriguez was advised that he was under arrest, while placing Rodriguez under arrest, he tensed up his right arm and began pulling away. Rodriguez was escorted to the vestibule, where Officer Manion and Wiley pinned Rodriguez against the wall

to restrict his movement and gain a position of advantage.

Rodriguez continued to prevent control by attempting to pull his arm away and twist his body, however he was finally handcuffed and transported police headquarters.

Once in the booking area Rodriguez had a complaint of wrist pain and was evaluated by UFD. He declined further medical assistance.

NEED ADDITIONAL INFO NOT PROVIDED On February 25, 2019 PO Wiley was dispatched to 132 Dryden Ave regarding a missing person return. Upon arrival he made contact with the parent, Danielle Doyle who advised her son, [REDACTED] had returned home from being missing. It was discovered that a female, [REDACTED], who was accompanying [REDACTED] was missing from the House of the Good Shephard on Champlin Ave. While arrangements were being made to transfer custody of [REDACTED] back to the House of the Good Shepherd both [REDACTED] and [REDACTED] were sitting on the stairs of the residence being passively resistant. PO Wiley requested another unit at which time Car 55 (PO Manion / PO Adis Gracinin) responded to assist. Upon their arrival PO Wiley closed his distance on [REDACTED] at which time he produced a black folding knife and lunged at PO Wiley. PO Wiley began to struggle with [REDACTED] on the stairs and PO Manion drew his taser, announcing he was going to tase [REDACTED]. Due to [REDACTED] not complying and him not dropping the knife PO Manion drew his service weapon and announced he was going to shoot [REDACTED]. During this time [REDACTED] had grabbed [REDACTED] in an attempt to assist with disarming him, which caused PO Manion to not have a clear and safe backdrop to discharge his firearm at [REDACTED]. During the struggle with [REDACTED] he was disarmed and the officers brought him to the ground in order to gain a position of advantage over him. After a brief struggle on the floor [REDACTED] was placed in handcuffs. At this time I had arrived on scene and [REDACTED] was making statements that he wanted to [REDACTED]. This coupled with his actions of lunging at PO Wiley with the knife I determined he was going to be arrested for the [REDACTED]. I contacted PO Parkosewich, due to [REDACTED] and advised him regarding the potential felony charges against him.

On 6/4/19 the PSU recived the closure narrative wrttien by Lt. Dougherty. While reviewing the IA Pro it was discovered that vital information was missing and the UOF report in RMS was not visable. After speaking with MIS Sgt Selimovic, it was learned that once the RMS record is sealed, it cannot be viewed or unsealed without a court order. At this time the information is unable to verified due to the current status of the resord.

On Tuesday, September 3, 2019 I, Sergeant Samuel M. Geddes reported to the Utica Police Department for the 0745-1600 hours shift. I was assigned to the Patrol Division as a street supervisor in Car 40, under the command of Lt. S. Dougherty.

During my tour of duty the Utica Police Department received multiple separate calls during the morning hours regarding a black male on a purple bicycle going up and down peoples driveways and looking in house windows. Due to this suspicious activity, I along with Car 58, PO T. Duval commenced area checks in and around the reported area.

At about 1109 hours, Car 58 and Car 51, PO C. Wiley were dispatched to [REDACTED] regarding parties trespassing in the yard. I also responded to the area to assist. Upon our arrival we conducted an extensive area check for anyone in the area. Through interviews of people in the area we checked, it was reported that the person in question was the black male on the purple bike that Car 58 and I were

attempting to locate. It was apparent that this male was hiding somewhere in the area as we had saturated the area and no one meeting the description was located.

At about 1128 hours PO Duval called out with a field interview at the intersection Garfield Street and Van Roen Road and moments later with a foot pursuit. I along with Car 51 responded to assist. Upon my arrival I saw that PO Duval and PO Wiley were struggling on the ground black male in the front yard of [REDACTED]. I now know the male to be b/m Andrew J. Mosca, [REDACTED]. As I approached on foot, I assumed control of Mosca's head, by pressing it to the ground as trained in defensive tactics refresher. PO Duval and PO Wiley were then able to apply handcuffs to both wrists, without further incident. I then spoke with PO Duval who told me that he spotted Mosca and initiated a field interview relative to Mosca's suspicious activity and that when he exited his vehicle, Mosca attempt to flee on foot and once tackled to the ground, Mosca continued to impede the investigation by actively resisting PO Duval's effort to place handcuffs on Mosca. Utilizing take down, soft hand/come along techniques Mosca was taken into custody.

Myself, PO Wiley and PO Duval completed Use of Force/Response to Resistance Reports regarding the incident.

No internal or external complaints.

Photos secured of myself, PO Duval, PO Wiley and Andrew Mosca, as well as the scene.

Lt. Dougherty was advised of the incident.

On December 20, 2019 at about 0805 hours PO Wiley and PO Jordan Dodge were escorting a prisoner, Vadim Verenich from his cell to the Booking Area bench in order for him to finish eating breakfast, and to prepare him for arraignment at Utica City Court. Once at the bench in the Booking Area Verenich began running towards the Matron's Quarters / female cell block and the officers gave chase. Verenich went through the door which separates the female and male cell blocks and then stopped in the male cell block area. Verenich then turns towards PO Dodge and throws the cup of orange juice he was holding in the face of PO Dodge. PO Dodge then delivers two hard hand strikes to the midsection of Verenich in order to gain an advantage over him. PO Dodge and PO Wiley then brought Verenich to the ground in order to maintain this position of advantage. Shortly thereafter several officer responded to assist with placing shackles and a belly chain on Verenich. Verenich was escorted back to the bench in the Booking Area where he was secured. Photographs were secured of the scene and Verenich which were downloaded into the system under this RMS number. The CCTV Footage from the Booking Area was also downloaded into the system under this RMS number.
