He has shown a strong desire to learn by working his assigned cases thoroughly and asking questions of his senior investigators and supervisors. Even though Bruzzese came to the unit with a relatively low amount of time on the job, he has demonstrated a basic understanding of the investigative process, which has helped him to hit the ground running. A couple examples of investigations that highlight this are:
- -On June 19, 2017, his first day in CID, Inv. Bruzzese was assigned an assault investigation that took place at Oneida Square (RMS 17-26992). He worked the case for several weeks before making an arrest of the suspect on 8/1/17. All of his investigative steps were documented in a thorough narrative that was written very well.
- -On September 15, 2017, Inv. Bruzzese was assigned a criminal mischief case involving Sacco's Locksmith and the neighboring residence, owned by Philip Donlon (RMS 17-41095). Bruzzese completed a thorough investigation, which included a successful interview of Donlon, who is a difficult person to deal with. The full confession that was obtained strengthened the case immensely and demonstrates that Bruzzese is developing good interview skills.


### SERGEANT FRANK SCARCHILLI, OFFICER FREDERICK BRUZZESE and OFFICER SEAN FLANAGAN

On the morning of December 30<sup>th</sup> 2016, at approximately 5:00 a.m., officers were dispatched to the 500 block of Milgate Street, regarding a man in possession of a weapon. Upon Officer Sean Flanagan's arrival, he located a thirty year old man standing on his front porch with a handgun, demanding that the police shoot him and take his life (suicide by cop). Sergeant Frank Scarchilli, along with Officers Frederick Bruzzese, Joshua Skibinski, Dzevad Bajrektarevic, Michael Balio and Carlie Heilig arrived on scene and took up tactical positions of concealment and cover, securing a perimeter.

Sergeant Scarchilli and Officer Bruzzese began a dialogue with the man but he continually refused to drop the handgun. Throughout the dialogue, the man made it perfectly clear that his intentions were to die at the hands of the police. To the credit of Sergeant Frank Scarchilli and the officers under his command, they showed enormous patience, concern and restraint with this suicidal person and after 30 minutes of talking with this person, in almost white out, snowy weather conditions, he surrendered peacefully.

The police officers on this call avoided a potentially tragic officer-involved shooting incident while risking their own lives to save this distraught man. Through their training and experience, these officers each did an outstanding job. They are all truly a credit to themselves, our police department and the City of Utica.



Moore began to run away but mistakenly ran into the metal tube railings around the stairway attached to the Lorretto Home and the officers were able to grab onto him, take him to the ground and place him into custody. As Recruit Officer DeMarco searched Moore, incidental to his arrest, he located a loaded, small framed, .22 Caliber semi-automatic firearm.
