### Chief Mark Williams,

I have looked back on the interview and wanted to reinforce a few things that I said. I truly have worked very hard for you and this agency during my career. I consistently commit myself to this agency so lam not just another 8 hour emproyee. I wear many different hats whether it be patrol supervisor, instructor, honor guard member or as a proactive officer on a directed detail. One of my proudest moments was when you promoted me to Sergeant on January 7, 2015. Almost 4 years have already gone by and I couldn't be any prouder to have been sitting in front of you again, this time for Lieutenant.

Lastly, I give you my word that no matter your decision I will continue to be the best supervisor I can and keep the same positive work ethic. I will always serve the Utica Police Department with dedication and integrity.



Mayor Robert Palmieri,

During my Lieutenants interview on October 23, 2018 you asked me that if I could change anything at the police department what it would be. I honestly was not prepared for that degree of a question and requested to answer you in writing. Since then I have thought a lot about that question. I believe that our police department is a very progressive department. We consistently lead the way in technology, training and the quality of our officers. I mentioned in my interview that I have attended and continue to attend trainings where I speak with other departments. I am regularly pleased to find out that we are ahead of the curve in police trends.

The only thing that I can come up with that I believe would be a beneficial change in our department is an amendment to our residency policy. This is a topic that has come up quite regularly over the last 4-5 years with officers. It was also mentioned that it was a big topic during our last contract negotiations. We were told by the union that you were open-minded to the idea at that time. I also know that this was a referendum created by the previous administration and that the common council would have to step up and push for changes.

Before I get into this to deep I want to say that I understand arguments for both sides but will speak to what I see as a Sergeant in the patrol division. First, Officers knowingly get hired (even sign a document) that they will have to live in the City of Utica for the duration of their employment. The argument to this is that Officers are typically in their mid-20's, no spouse or kids and would sign about anything to pursue a job in law enforcement. Then within a few years things begin to change in their life and after some discussion with their spouse living in the City may or may not be what is best for their family. I for one have had this conversation with my wife dozens of times. She works at Oneida Hospital, has a good job that she enjoys and would like to live closer so she doesn't have a 40 minute commute every day.

Another argument would be that we seem to lose a lot of officers to other agencies because of this referendum. It has been mentioned that during exit interviews residency is a top reason an officer leaves. I myself have spoken to officers that have said that they would have stayed if they could move outside the City for whatever reason. On the flip side of that I believe that it would drastically open up our candidate pool for both the civil service test and lateral transfers. My academy class in 2009 had 13 Utica officers. Only 6 of us are now left and almost all of them blamed residency for leaving (even officers that left for the state police).

Some officers have had off-duty encounters at their homes with people they have arrested. In some cases a stay away order of protection was issued from the courts to deter further threats towards the officer, officer's family and home. This obviously was concerning to the officers families and moving outside the city would have been a small piece of mind for them.

Lastly regarding residency I have done some short research and found that we are the only agency in New York State (that I can find) that has a strict career long residency policy that restricts officers within the City.

In closing I want to thank you for meeting with me on Tuesday. I truly value my career with the Utica Police Department and am proud to be a member of this great agency. I have always worked hard for this agency and aspire to further my leadership role. No matter the decision that is made I will continue to serve the Utica Police Department with dedication and integrity.
