I would like to thank you and your department for the assistance provided to members of the Rochester Police Department during the month of August 2018. The Rochester Police Department's Major Crimes Unit (MCU) and Special Investigations Section (SIS) were investigating a group who were involved in narcotics sales, and who were suspected in several violent crimes in the City of Rochester. During our investigation, [REDACTED] in Utica, NY was identified as a source for narcotics distribution, and it had relevance to our case. A search warrant was obtained for [REDACTED] and with the help of Lieutenant Brian Bansner, SWAT entry was arranged and additional resources were obtained.

On August 14, 2018, several investigators and supervisors from the Rochester Police Department met up with Utica PD and Metro SWAT personnel and the search warrant was served at [REDACTED]. Quantities of heroin, cocaine, marijuana and cash were recovered and the target, Clifford Billins was taken into custody. Please be advised that on Wednesday, January 24, 2018, the above named defendant plead guilty to a three count indictment charging him with Rape, Aggravated Burglary and Aggravated Robbery. He waived a presentence investigation and agreed to serve a nine (9) year prison sentence. Following his release from prison he will be required to serve five (5) years of post-release control.

This sentence was the result of a December 1996 cold case that was solved after a CODIS match was made almost 20 years after the fact. The victim, who was 75 at the time of the crimes, had since passed. After re-opening the case local officers were able to track the Defendant down to Utica, New York. Our local officers were assisted by Sgt. Stanley Fernald and Sgt. Michael Murphy of your department. These officers were able to obtain a DNA sample that confirmed that Jack Sheetz was in fact the perpetrator of these crimes. Additionally, your officers met with and assisted our local officers when they arrived in Utica and were prepared to come to Warren, Ohio to testify in a potential Motion to Suppress that was eventually cancelled due to the plea.

Please accept this letter as thanks for these officers and your department's assistance in this cold case conviction. Thanks to the assistance and efforts of Sgt. Stanley Fernald and Sgt. Michael Murphy a 20 year old violent crime has been solved and the perpetrator has been sentenced to prison where he belongs.
