ITEM #1 Approval of proposed use and exterior signage at 110 Business Park Drive

Appropriation of Fund Balance in the amount of \$70,000.00 to provide the local match for a grant of \$623,000 from the State Environmental Facilities Corporation to convert the eastern portion of the URA-owned Car Park parking lot into a multi-purpose event space utilizing 'green' infrastructure. This appropriation was originally approved by the UURA Board at its February 11, 2021 and then again at the December 22, 2022 meetings (which would have affected prior fiscal years); however, draw-down of funds was not necessary until recently, thereby necessitating a re-appropriation in the current fiscal year.
