Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

<p>B.3</p>	<p>Progress Report.</p> <p>Provide a description of the PHA's progress in meeting its Mission and Goals described in its 5-Year PHA Plan.</p> <p>The City of Utica Section 8 Program continues to reinforce our mission to assist persons in need of safe, decent and affordable housings. We continue to successfully implement all HUD voucher programs allocated. We have provided various supports to our participants and owners over the course of the pandemic including; increased program payment standards to 110% above the FMR to assist program participants in lease ups; have expedited downward interim adjustments; and continue to educate program participants and landlords on program obligations and the importance of maintaining good standing with lease requirements.</p> <p>The program continues to provide both landlords and tenants with engagement tools and resources to help the two parties develop better relationships, and maintain program and lease requirements. Our goal is to empower landlords and tenants to resolve differences presented to the program and avoid eviction courts. The City of Utica Section 8 program continues to make referrals to local service providers, including landlord/tenant mediation services, and repayment agreement specialists, to assist in such circumstances presented to our office.</p> <p>In addition to the above mechanisms, landlord engagement has been emphasized throughout the program year. In October of 2022, the City of Utica Section 8 Program hosted its first, city-wide, Landlord Engagement and Resource Event at City Hall. The event had over twenty-five area service providers and community resources offered to address landlord needs and concerns. Aside from resource tables with expert staff and reading materials available to attendees, a symposium of guest speakers presented, including our housing authority, and neighboring public housing authority. HCV program providers took the stage to engage the crowd of owners regarding voucher programs, and owner obligations; shared myth-busting common misconceptions of the programs; and addressed landlord incentives. It was a successful and well attended event the department plans to continue for years to come. We are currently working on incorporating a similar tenant event for next program year.</p> <p>The program continues to address homelessness and homelessness prevention in the City of Utica. This year, the program participated in a Homelessness Study organized by professors and students of Hamilton College and NYU. The study was funded by the City of Utica. We anticipate the results of the study, which will indicate how we can better assist those in our community with housing stability. This study emphasized high-risk, hard-to-house individuals.</p> <p>Over the past program year, the City of Utica has successfully implemented a fully utilized EHV program, and continues to receive referrals from our CoC partners. We have also developed stronger relationships with landlords throughout the city to lease up this hard to house populations. Landlord incentives for this program have been offered to further engage landlords. This has assisted in ensuring successful lease ups to high-risk participants.</p> <p>The program also worked to update the FSS Action Plan to be compliant with new HUD regulations to better serve our participants. The FSS program continues to expand its network amongst community resource providers to provide the best referral services to the clients we serve. Many of the organizations involved also work to serve the HCV participants.</p> <p>The City of Utica Section 8 Program collaborated with community partners to assist in the recruitment of qualified and diversified staff to reflect the population in which we serve on our programs. This program year, we were able to recruit new staff to fill vacancies and provide the public with a multi-lingual, diverse team. Through these recruitment mechanisms, we have continued to expand and better our program's communication with non-ESL speaking landlords and tenants throughout the city.</p> <p>The program continues to engage in various staff development mechanisms in order to better serve the public, and equip staff with resources and tools needed to be successful in their role of serving others. Throughout the pandemic, these stressful and turbulent times led to observations of elevated landlord/tenant disputes, escalation of mental health related concerns, and other circumstances. Staff were required to participate in the following trainings listed to help navigate clients throughout these challenging times; de-escalation techniques, customer service, emotional intelligence/competency/building empathy, mental health resources, and safety training.</p> <p>The City of Utica has reached its goal to administer alternative remote communication mechanisms with our client base and the general public. Clients can now reach us remotely through our software system to request needs and submit information. Applicants can also access and update their information on our new remote software system. The public can now apply to our programs online. These remote capabilities are a welcomed addition to our office. Clients are also beginning utilize these updated services as opposed to more traditional communication mechanisms.</p>

Furthermore, under Section 5A(d)(15) of the U.S. Housing Act of 1937, as amended, a PHA must submit a civil rights certification with its Annual PHA Plan, which is described at 24 CFR 903.7(o)(1) except for qualified PHAs who submit the Form HUD-50077-CR as a standalone document.

This information collection is authorized by Section 511 of the Quality Housing and Work Responsibility Act, which added a new section 5A to the U.S. Housing Act of 1937, as amended, which introduced the Annual PHA Plan.
